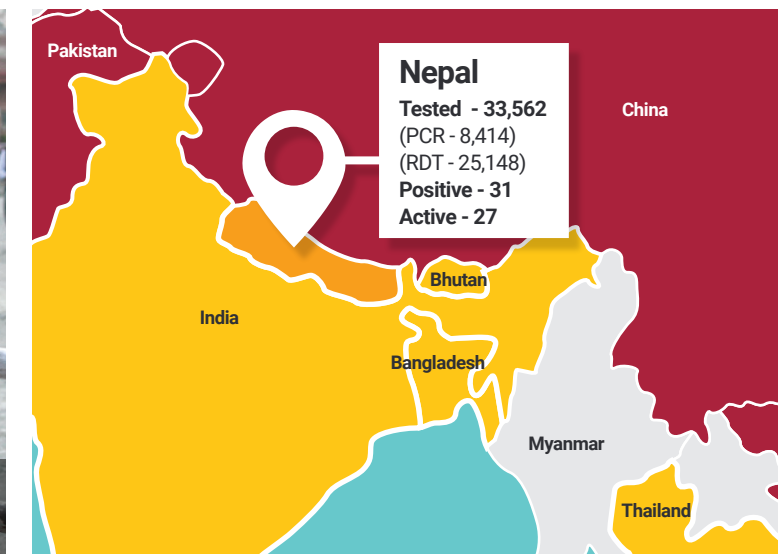

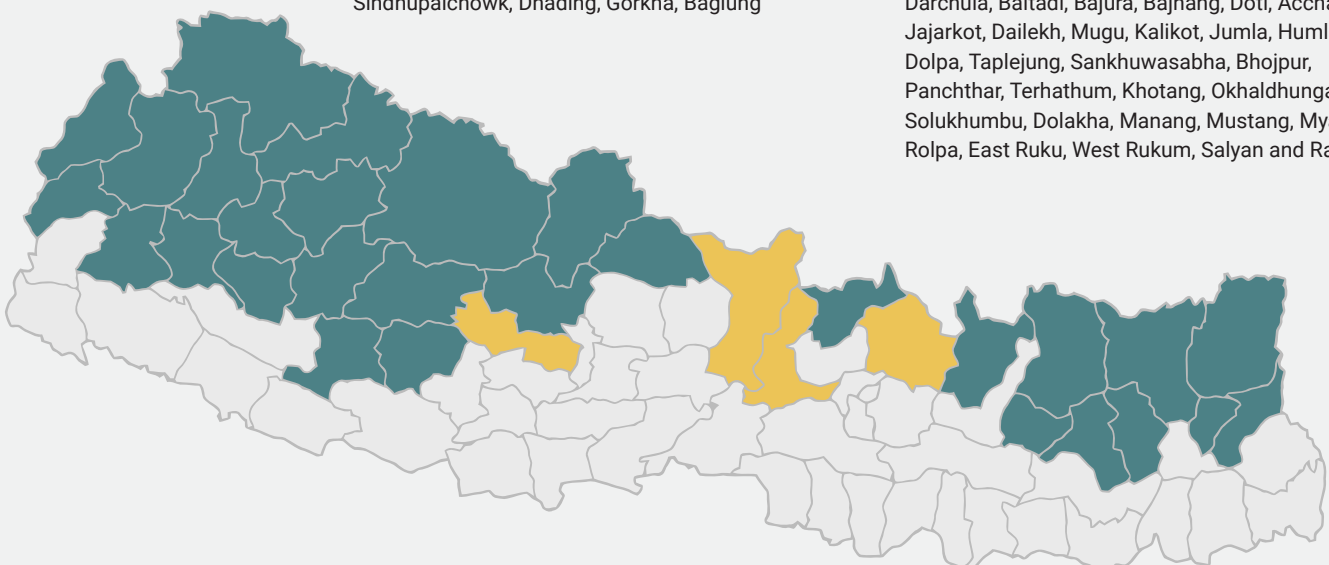

The number of individuals in quarantine is decreasing whereas the number of infected individuals is increasing. What does this suggest?

As of today, the number of individuals in quarantine is 5,180. This number is decreasing day by day. The reason behind the decline in numbers is that the government has broadened the horizon of the tests and the people who test negative are sent back to stay in home quarantine.



The concerned department and headquarters have been directed to deduct the salary of their government service employees and deposit in the Corona Prevention Fund.

The Council of Ministers has directed the concerned authorities to make arrangements for a voluntary contributions of the government employees who directly get involved in corona prevention and treatment including the health workers and security personnel in the Corona Prevention, Control and Treatment Fund.



The students of school and university seem completely deprived of education at the moment. There is a chance that the lockdown will increase. What is the government's strategy on this issue?

The Ministry of Education, Science and Technology has decided to allocate Rs. 7 crores for the online classes of school and university level. Around 75 lakh students from the school and university level will be benefited from this program.

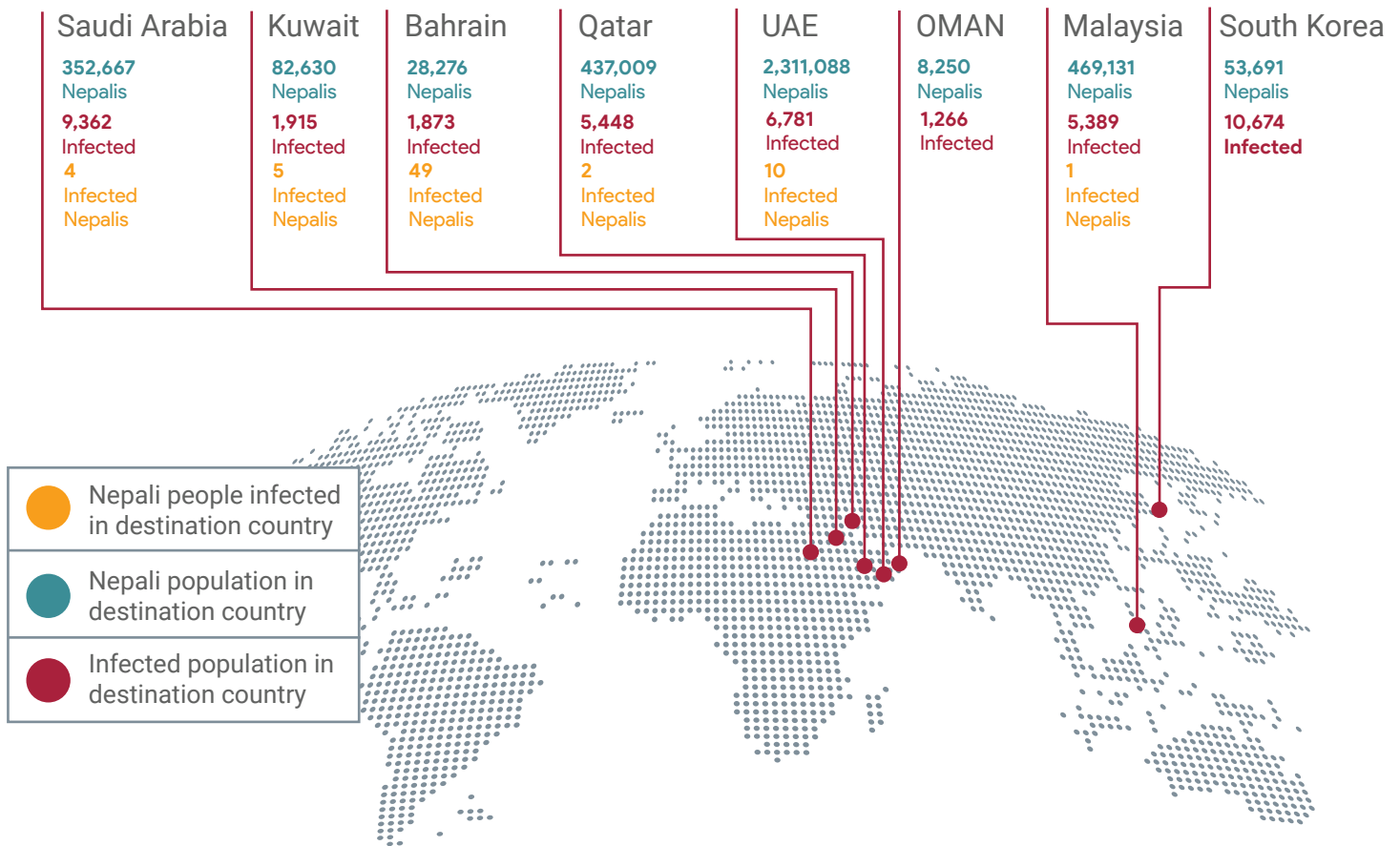

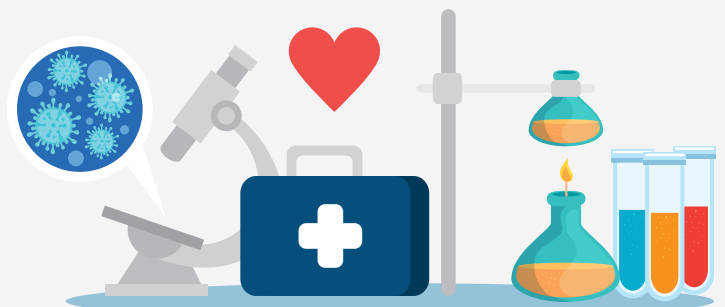
Some of the new decisions implemented by the government of Gulf Countries



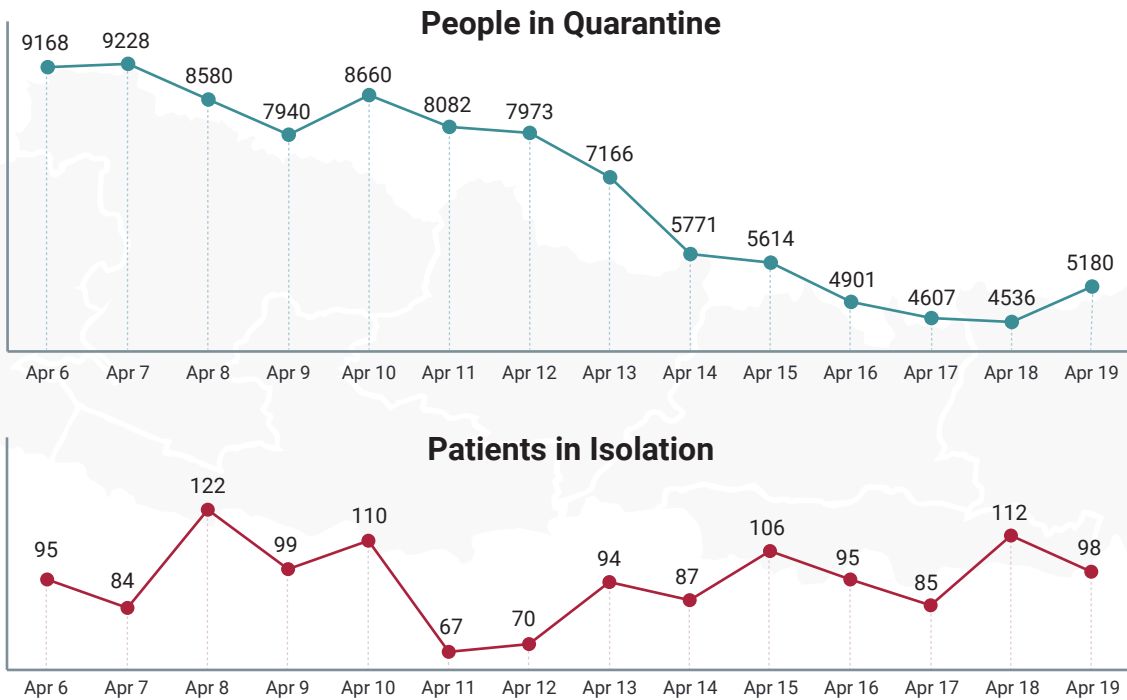
Kuwait: The Kuwait government has announced that in case a visa of a foreigner has expired, the visa will be automatically renewed for 3 months. This facility is effective from March 1 to May 31, 2020. An online service platform is available for those who need to renew their visa under other circumstances.

Bahrain: The Bahrain government has announced to give amnesty to the foreign nationals residing illegally, which will be effective from 7 April 2020 to 31 December 2020.

UAE: Corona tests are performed for free in Abu Dhabi, Emirates, and Mussafah for the laborers. The first phase of this test is being conducted near Hyundai Showroom in Mussafah -12 and near Mussafah Market in Mussafah - 43. Similarly, this facility will also be provided to the individuals above the age of 50, and those who show the symptoms of coronavirus.



A need for clear protocol on quarantine and isolation



The above graphs show that the total number of people in quarantine has almost halved in the last two weeks. However, the number of patients in isolation is fluctuating on a day-to-day basis and is somehow stable over the weeks. This raises a concern about whether or not a proper protocol is being used to determine who needs isolation during quarantine and for how long.

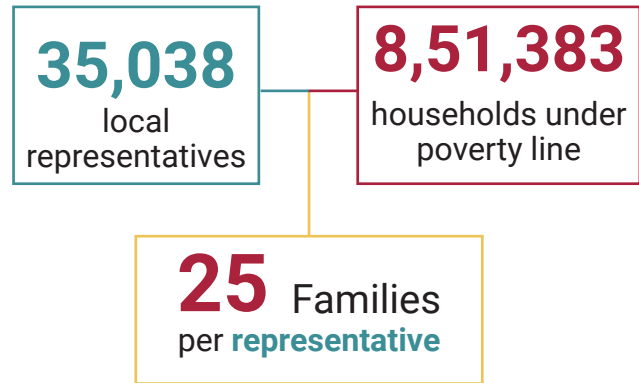

Role of Local Government in the COVID-19 Pandemic

According to the Annual Survey 2016/017, there are 56,06,235 households in Nepal. There are more than 35 thousand people's representatives in local governments. If one representative monitors 160 families, then the problems of all families can be solved. Similarly, according to the same survey if 15.2% (851383) households under the poverty line are given special attention, then one representative can look after 25 families enabling local government to reach the doorsteps of every household.



It is the constitutional responsibility of the local government as per Schedule 8 (5) of the constitution to collect data and keep a record of the vulnerable citizens within their jurisdiction. Financial and food assistance, health service, psychosocial counseling, and information is the need of the pandemic. To provide these services, pocket areas should be identified and a mechanism should be created and mobilized in the leadership of the ward.

Make arrangements for the food and other necessary relief for the individuals with low economic status and daily wage workers and distribute it in their local unit. Also, coordinate with wards to make a contact list of the grocery, medicine and other essential supplies distributors and regularly circulate information related to it among the public.



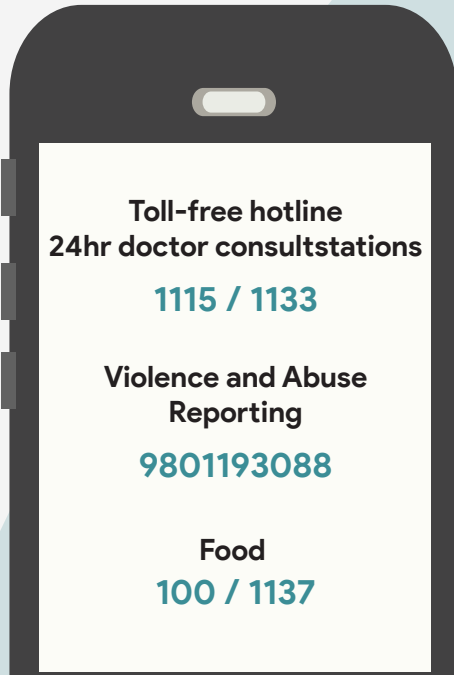
Other Suggestions

- Provide transparent information about the government's work, location and time of service delivery, details of the expenditure, and support received covering all the areas of the local unit through telephone, online news portal, a government website, social media, posters, and other mediums. The monitoring opportunities for the citizens should be provided as anyone can be involved in irregularities during the crisis.
- There are several news published about the laborers and individuals facing difficulties in managing their livelihood returning to their home walking from Kathmandu valley. The local government has to coordinate with the security bodies and relevant stakeholders to arrange transportation, rescue and manage quarantine facilities for them. (Chaukune Rural Municipality, Surkhet - rescued 12 people from Jhapa sending a microbus)
- Creation and use of a mechanism at citizen's level to build confidence and guardianship through constant communication and support: Use of social media to listen to their concerns, being constantly present for phone contact (Belaka Municipality, Udayapur)
- Mobilizing female health volunteers in communities to raise awareness about the challenges posed by COVID-19 and establishing health desks in coordination with ward offices to provide essential health services and information.

Where can I get a coronavirus test?

The National Public Health Laboratory (NPHL) Teku, Kathmandu, Bharatpur, Dhulikhel, Bhairahawa as well as all provincial hospitals are conducting tests. As the person suspected to have the virus needs to be isolated, the sample is collected by hospitals and sent to the NPHL.

Is the sick person allowed to go to the lab to get tested? How much does it cost?

The sick person is not allowed to go to the lab directly. The local hospitals will refer to the NPHL to test if suspected. There is no cost for the test.

How long does it take to see the results of the test?

The test report is provided between 24-48 hours after the sample is submitted to the lab. If the report is positive, the concerned hospital or the doctor is informed.

The sources of rumors, information and issues presented here are collected from a variety of organizations and individuals including the Ministry of Health and Population, the World Health Organization (WHO), social media and the CivActs team based on their conversations with over 2000 people in April 2020. The issues highlighted are chosen based on prevalence, relevance and potential impact. The information presented here is correct at the time of issue.
