

The Nepal Electricity Authority (NEA) has decided to provide some facilities to the customers considering the fact that most of the locations in the country had been under lockdown due to COVID-19 in Bhadra. In this regard, the time of levying exemption and adding the fines have been changed. No additional fine will be charged if the bills are paid by 22 Asoj 2077. Only 5 percent additional fee will be charged while paying the bills from 23 to 30 Asoj.



New procedure workers in Qatar should follow when changing companies

According to a new law introduced by Qatar, employees no longer require the NOC to change companies. Here is the procedure one should follow:


- 1. You should inform the company you are working now. If you have been working for less than 2 years, then 1 month, if it is more than 2 years, 2 months and if the time period is specified in the contract, then 30 days prior notice has to be given. If the time period is not specified in the contract, then 60 days notice should be given only after 5 years.
- 2. While giving the notice about the change of employer, you should go to the information system of Labor Ministry, Qatar at https://bit.ly/ADLSA-ENS and submit the contract letter of the company you are leaving, offer letter of the company you will be working in and form you have filled to change the company along with other documents.
- 3. The new employer company signing the employment contract should prepare the contract based on the discussion with the worker. The contract will go to https://elcr.adlsa.gov.qa/ for the verification from the Labor Ministry of Qatar.
- 4. Now the work of making new Qatar's ID has started. Once the contract is authenticated, the new employer will request a Ministry of Interior for a Qatar ID and the new employer is responsible to create a Qatar ID and health card.



"Everyday, 40 to 50 patients come to the health post for treatment. Those with symptoms can be recognized, but the thought of how to stay safe from those who show no symptoms and how to protect my family worries me. We have been urging the general public to come to the health post wearing a mask. Some service seekers even get angry when we ask them to wear masks. I have been coming from my own house located in Bankatta, Sainamaina, Rupandehi. Those who used to come close to me earlier have now started to maintain distance. Seeing this makes me both happy and sad. The perception of people towards health workers is getting negative with the corona pandemic".



"I am assigned the management of an isolation center built in Devdaha Adarsha Bahumukhi Campus. The fear of having to work closely with an infected person is already there, but the even greater fear is for the child and elderly mother at home. My mother is a diabetic patient. I stay careful to not let my family face any catastrophe because of me. Initially, I stayed in the quarantine. Now I travel back and forth from home. I see people maintaining distance instead of being happy while seeing a health worker. The friends also avoid me telling me that you must have come from an isolation center. But also, I am proud of the service".

Nepal's active to recovered ratio of COVID-19 cases compared to other SAARC countries

Percentage of active, recovered and death cases of COVID-19 In SAARC Nations



Compared to other SAARC nations, Nepal has the lowest recovery ratio and highest active cases ratio of COVID-19. This shows that infection in Nepal is still in increasing trajectory and at a growth stage in South Asia. As lockdown has been lifted with minimal restrictions, and the festive season is approaching; data shows that Nepal is yet to see a positive outlook for the control of COVID-19 Infection.
