





**What should be done in the UAE if a company doesn't pay the salary?**

According to the law, any company has to pay its workers as per WPS (Wages Protection System) through a bank or financial institution as per the rules. The salary should be paid within 10 days of the end of the month. If the companies do not do so, MOHRE (the institution overseeing the relations between company and worker) will take actions against the company.

Any problems related to workers including salary can be raised with MOHRE. However, a complaint filed by the worker is heard only if the company is at fault. Since many things depend on the agreement with the company, it is important to know what is in the agreement before filing a complaint.





## Total expenses by the Government of Nepal until Shrawan 2077 to Fight Against Coronavirus



## Cost of three lakhs just to return home



I went to Dubai a few years ago for employment. My visa was valid only upto 12 Chaitra 2076. After the visa expired, I bought a ticket to return to Nepal on the 12th itself. The money for the ticket was wasted as lockdown started in Nepal. It was said the money would be returned, but it hasn't been returned yet. I stayed there for 4 months from Chaitra to 10 Shrawan 2077 at my own expense. I spent about 1 lakh 50 thousand during my stay. Hundreds of thousands earned by months of hard work there was spent just by sitting idle there.


I came to Nepal on 10 Shrawan after buying a ticket worth NRs. 70,000, while the ticket worth NRs. 70,000, while the ticket would cost only NRs. 17,000 prior to that. I had to stay in Kathmandu for four days. There was no proper food and accommodation during that period. After spending about NRs. 12,000, I reached Surkhet. I stayed in a place called Subbakuna in Surkhet for one day. Then, I stayed in the quarantine at the ghantaghar in Birendranagar and went home from there. What would cost NRs. 50,000 to reach home at other times cost me 3 lakhs to reach home this time.

I am living in the village now as the situation hasn't returned to normal. There is no earning environment here. I have plans to go abroad again after the situation returns to normal. I have a compulsion to earn more this time as returning home cost me more than any other time. The local level here hasn't created a working environment for us. There are some employment-generating jobs in the municipality, but those programs are very short term. Wages aren't good either. In this case, we can't afford to stay here. I have been waiting for the situation to return to normal and apply for a visa. When will this situation compelling us to go abroad end ?

## Percentage of Positive Cases out of Daily PCR Tests in Nepal (20 Oct - 1 Nov 2020)



The above graph shows the ratio of positive cases out of all PCR tests performed in Nepal between 20 October to 1st November 2020. Besides a couple of high and low dips, the ratio is static over this period with an average of 24 percent of cases being positive each day. This is an alarming scenario which indicates the massive transmission going on in crowded cities like Kathmandu. If the volume of tests are increased, data shows the positive ratio increases accordingly. This has two implications: first, COVID-19 shows no sign of slowdown in Nepal and second, increasing the volume of tests is the only way forward to understand the true extent of the infection.
