

The **Coronavirus CivActs Campaign (CCC)** gathers rumours, concerns and questions from communities across Nepal to eliminate information gaps between the government, media, NGOs and citizens. By providing the public with facts, the CCC ensures a better understanding of needs regarding the coronavirus and debunks rumours before they can do more harm.

The payment process of the Corona Insurance claim

The following documents should be submitted to the insurer (concerned Insurance Company) for the claim within 15 days of the discharge of the insured individual from the hospital or the PCR report confirming negative:

1. Completely filled claim form
2. All the original documents confirming the corona infection, records of the Health Ministry, and the recommendation of the concerned local level in case of those living in home isolation
3. Bills of the medical cost and related expenses made as per the written advice of the doctors in case of those who were admitted to the hospital
4. Documents of admission and discharge for those who were admitted to the hospital and the written proof about having stayed in isolation from the designated isolation center
5. Other details and documents mentioned in the Corona Insurance Standards, 2077 issued by the Insurance Committee

Cases where the claims won't be considered (Exception)

1. If the individual was infected with coronavirus before the policy was introduced and within thirty days from the date the policy was issued.
2. If the cost of treatment and other expenses incurred by the Government of Nepal or other organizations are included in the claim.

The concerned insurance company has to pay the insurance amount within 7 days from the insurance claim. The term of the policy will be from the date of issue of the insurance till end of Ashad 2078.

It is heard that the government will now provide employment to all the unemployed citizens through the Prime Minister Employment Program?

The government has promised to provide 100 days of employment to the unemployed individuals listed at the local level. It has been said that in the employment created through the project to be implemented by the local level, the first priority should be given to the individuals listed at the top of the unemployed list and accordingly the individuals below them should be approached for 100 days employment subsequently. For this, the wages of the workers, the number of individuals involved in the employment and other details should be made public through the information board of the employment project in the language that everyone understands.

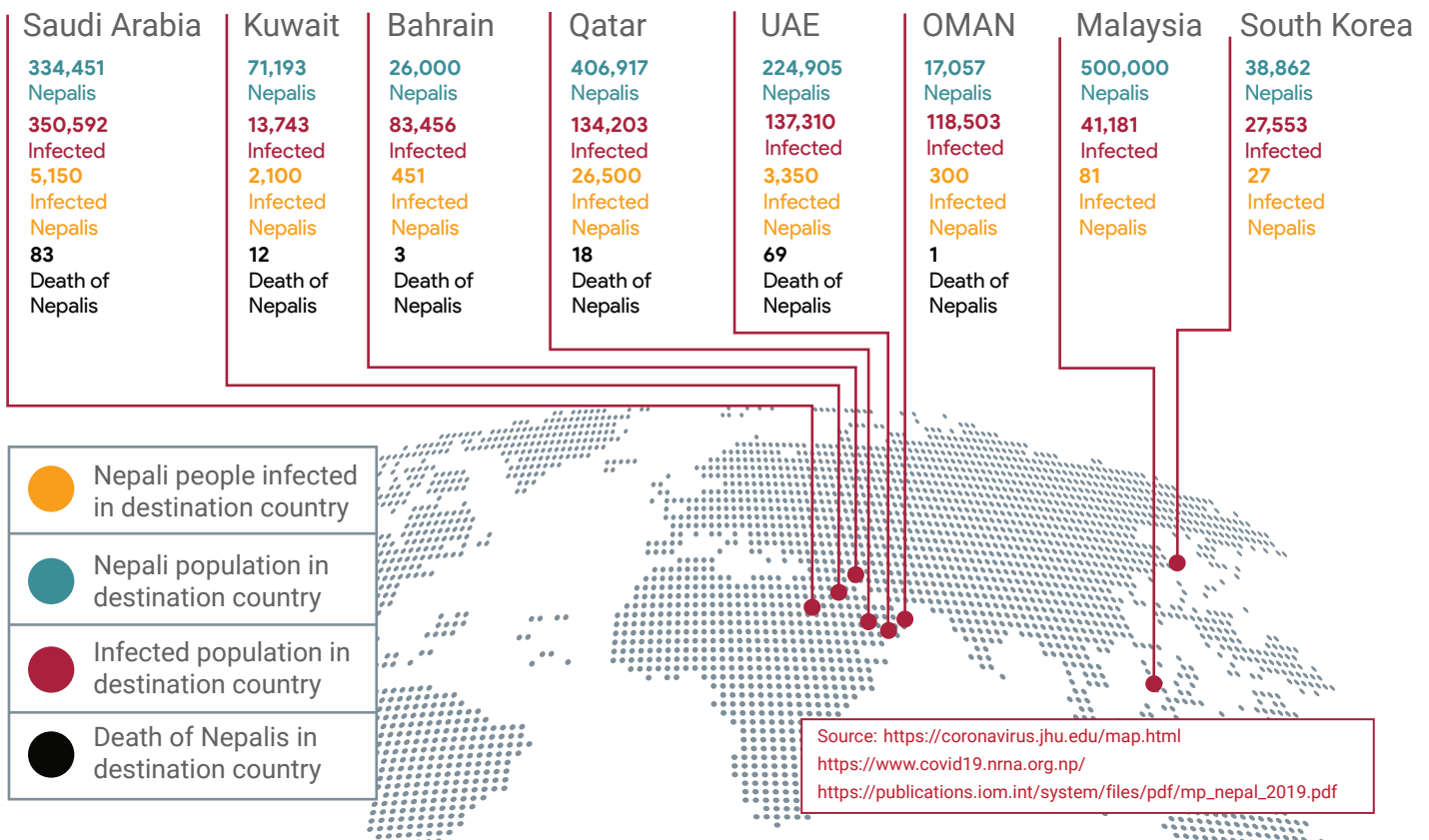

What is the law related to social media in the UAE?



The UAE introduced cyber law in 2012 and social media law in 2019. According to the law, anyone who misuses social media (Facebook, Youtube, Twitter, Tik Tok) is liable to a fine of up to 5 Lakh Dirhams (NRs. 1,50,00,000) and imprisonment.

Things we need to understand:

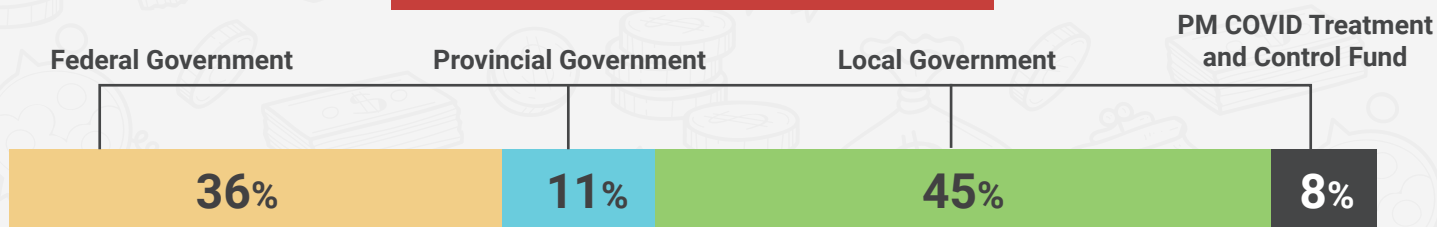
1. No content should be posted on social media that sends a wrong message about any person, organization, religion or community. Even if someone has posted such a message, it should not be shared.
2. Action will also be taken against those who comment on such posts or make similar comments on other posts.
3. Nobody's photo can be posted on social media without their permission. Further, videos or photos cannot be taken without permission.
4. If the source is not disclosed while copying or pasting what someone has posted, action can be taken in case if a complaint is lodged.

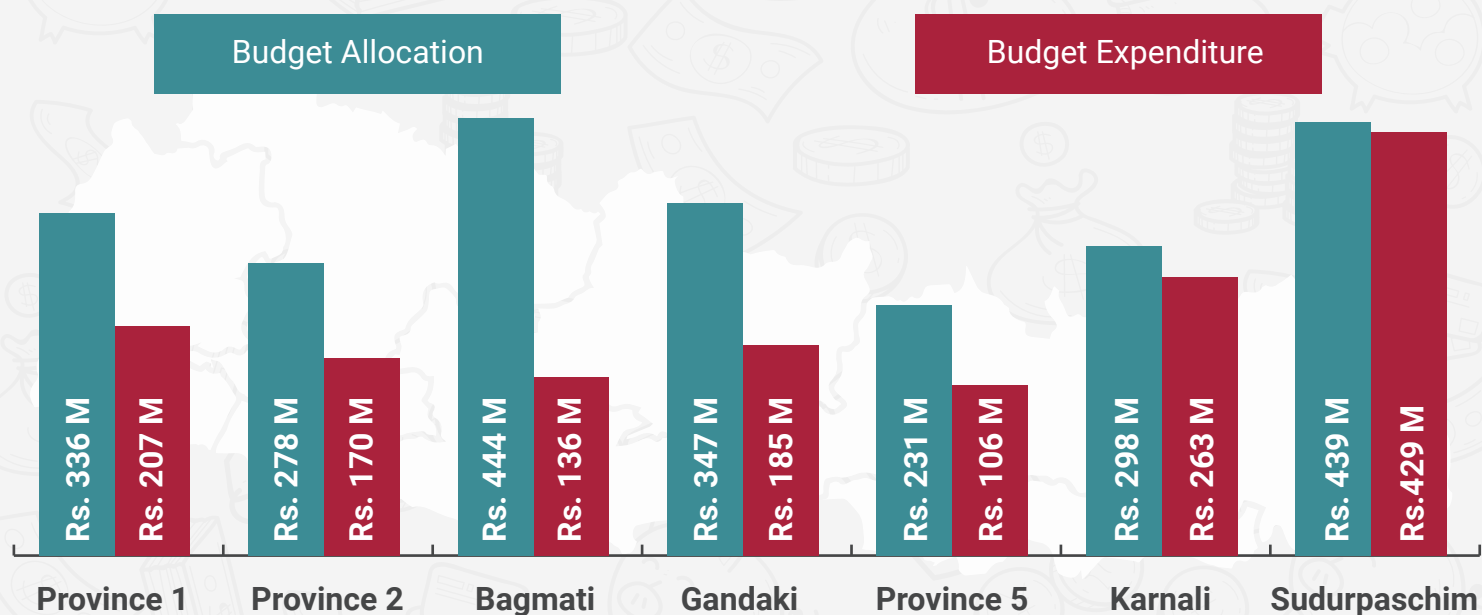

Maniram couldn't return home country even after the contract period had ended



Maniram Khatik, who went to Malaysia for foreign employment, hasn't been able to return home even three months after his visa expired. Maniram, who went for foreign employment in December 2017, couldn't return home as his employer didn't return the required documents and passport. The family of Khatik who are a temporary resident of Nepalgunj Sub-Metropolitan City Ward no. 22 since 22 years are also worried as their son isn't being able to return. He works as a driver for a company. Because of Corona, the company has few workers.

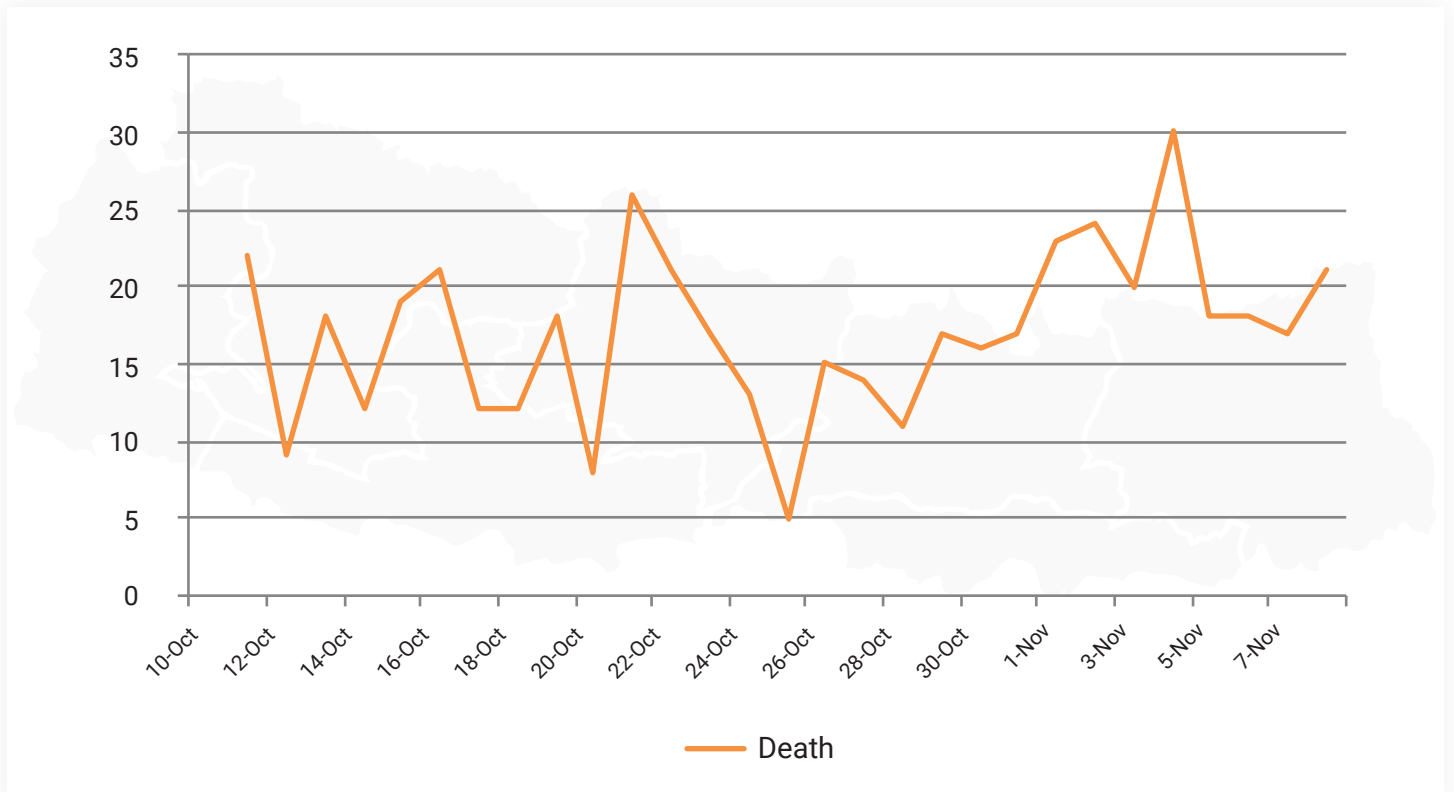
So, the company owner has said that he will not allow them to return home until more workers arrive.

The foreign employment regulations mention that the workers can return home voluntarily after the expiration of the contract period. Maniram who has pursued only basic education isn't acquainted with all these rules and regulations. He has become even more worried now that his friends are telling him that the possibility of new workers leaving Nepal is mere in the current situation. For the past three months, the company has only provided him with food and shelter, but he hasn't even received the minimum wage.

He is unaware about the procedure to return home in this situation. Earlier, the company used to arrange tickets for the flight and send them back to Nepal, but now the situation is different. On top of that, the company has started threatening at the conversation of returning home. Although he is currently going to work on a daily basis, he is waiting for the new worker to arrive and return home. He is only one representative of those who have been deprived of the right to return home on their own will even after the expiry of the contract.



Daily Deaths by COVID-19 in the Last 30 Days in Nepal



The above graph shows the number of daily deaths by COVID-19 in Nepal. In the last 30 days, the total number of COVID related deaths increased by 80 percent. As a large number of infected are now in home isolation and with very limited government help, this data is the clear indication that people are lacking proper care and critical support to fight COVID-19. This has contributed to the high death rate recently. There is an urgent need to identify, manage and support patients, especially in home isolation and provide financial assistance to those who can't afford it.
