



The Kathmandu Metropolitan City issued a strict notice announcing a complete ban on street vendors on 10 January 2023. The metropolis has stated that anyone operating a street business will receive severe punishment, and the goods will be confiscated. Although the government's intention to ban street vendors is to open up the streets for pedestrians and vehicles, the decision has received immense backlash for not finding proper alternatives that don't completely deprive the poor of earning their livings.

According to the Street Vendors Trade Union, there are more than 15,000 street vendors in Kathmandu affiliated with them. Besides, there are an estimated 30,000 vendors, including those who aren't affiliated with the union. This shows that a huge number of people, considering the vendors' families, rely on income from street vendors. Similarly, as per the rough data, more than 55 percent of the street vendors are women who are single, victims of conflict, and affected by the pandemic. These women may lack the skill sets to relocate to other professions immediately.

The metropolis earned NRs. 3.6 million in the last year auctioning the confiscated goods from street vendors. Yet, they seem to have made no effort to support these poor people who do not have alternative means of earning. There are rising voices from civil societies and the public that the metropolis can allocate specified places and time for such businesses or come up with other plans for their income.
