Urgent Call for Accountability on Bal Mandir Land Embezzlement Case

marks a significant development in the case of illegal embezzlement of 1.45 hectares of land belonging to Bal Mandir by Brihaspati Vidyasadan. The arrest warrant came following the complaint of Bal Mandir against the Brihaspati Vidyasadan, run by the Vishal Group in the Central Investigative Bureau (CIB). Among those implicated are former Nepal Bal Sangathan chairperson Rita Singh Baidhya and other members, alongside former Brihaspati chairpersons and directors. The initial lease agreement to Brihaspati Vidyasadan stated a 5% rent increase every two years excluding the first and last five years of the agreement. However, 16 years before the expiration of the lease, Brihaspati Vidhyasadan secured a mysterious deal of 1.48 hectares of Bal Mandir land for 6 rupees per square foot. In addition to the deal secured for the surprisingly minimal amount, a deal to hand over the land for another 43 years from 2088 BS was also sealed on the same date.
